EXECUTIVE SESSION

No Executive Session was held.

MINUTES

Executive Committee meeting minutes from January 2023 were electronically distributed to members prior to this meeting for their review.

Trent Bowers moved, and John Marschhausen seconded the approval of the minutes for January 2023. The motion passed unanimously.

FINANCIAL REPORT

A. Fiscal Report

Tony Podojil provided a summary of the financial activity for January 2023. Tony indicated that revenue and expenditures remain on target as we move into the second half of the fiscal year.

A copy of the financial report was electronically distributed to members prior to the meeting.

Steve Estep moved, and Fred Bolden seconded the approval of the fiscal reports for January 2023. The motion passed unanimously.

EXECUTIVE DIRECTOR'S REPORT

A. Major Bills Under Consideration:

1. **SB 1 (Reineke) Reform function, responsibilities, accountability of state education office to emphasize education, workforce development.**

- an authorization for the legislature to rescind or invalidate any administrative rule adopted by the Department of Education and Workforce (DEW)
- a prohibition on the DEW director and deputy directors from holding office for more than 45 days without being confirmed by the Ohio Senate.
- Senate Republicans will attend their legislative retreat next week (Jan. 24-25) in Northeast Ohio and will return the following week to resume legislative activity.

2. **SB11 (O'Brien) Universal eligibility of Ed Choice Scholarships (Parent Educational Freedom Act)**

This is a universal voucher program sponsored by Sen. Sandra O'Brien. It would qualify all K-12 students and incoming kindergartners for an EdChoice voucher regardless of their income or residence. It also increases the amount of homeschooling expenses that a taxpayer can claim as an income tax credit each year, from \$250 to \$2,000. The nonpartisan Legislative Service Commission estimates the cost of universal vouchers at \$536.4 million annually and each year thereafter. With public school students transferring to a private school under a voucher, there may be a state savings effect depending upon the level of state funding that district receives, leaving the projected net annual expenditure at \$527.6 million. The tax credit changes will reduce state revenues by roughly \$40 million annually. The bill received a first hearing on Feb. 7.

3. **SB 49 (Reynolds) - Requires each kindergarten through 12 public school to adopt a policy providing students with religious accommodations (Religious Expression Days "R.E.D." Act)**

- Requires each public school to adopt a policy that reasonably accommodates the sincerely held religious beliefs and practices of students, which includes three excused absences for religious expression days.
- Requires each public school to adopt a policy permitting teachers and staff to take up to three days of religious expression leave per school year.
- Entitles the bill the "Religious Expression Days" or "R.E.D." Act.
- Bill was amended in the first hearing to remove the mandated 3 leave days for school employees.

4. **HB 1 (Mathews) - Revisions to property taxation and income tax rates**

- Consolidates the state income tax brackets into one single flat income tax rate of 2.75%.
- Eliminates the 10% property tax rollback, a credit the state pays on property owners' behalf to schools and local governments, currently valued at \$1.2 billion statewide.
- Revises the 2.5% owner-occupied property tax rollback to be a flat \$125 credit.
- Modifies the homestead exemption program to increase amount and apply it to legacy homeowners.
- Reduces the property tax assessment rate from 35% to 31.5% (a 10% decrease) and requires it to be adjusted downward based on market factors.

5. **HB 6 (Powell) - Require schools, colleges, and universities to designate separate single-sex teams and sports for each sex (Save Women Sports Act)**

- Requires the designation of separate athletic teams for participants of the female sex and male sex.
- Explicitly prohibits male participants from participating on teams or in competitions designated only for participants of the female sex.
- Does not include previous versions' provisions regarding gender exams.
- Applies the bill's provisions to K-12 and higher education.

6. **HB 8 (Swearingen/Carruthers) Requires public schools to adopt a policy on parental notification on student health and well-being and instructional materials with sexually explicit content (Parent's Bill of Rights)**

- Prohibits school personnel from encouraging a student to withhold from a parent information concerning the student's health or well-being, unless that disclosure would result in abuse, abandonment, or neglect.
- Establishes a process under which the district or school must resolve written concerns submitted by parents about topics addressed in the bill.
- Requires a notice to parents about sexually explicit instructional materials, an opportunity to review them, and an opportunity to request alternative instruction.
- Requires a notice to parents about school-provided healthcare services and requires districts to create a healthcare plan for students.
- Requires a notice to parents about changes to the health services that provide a safe learning environment; and
- Titles the bill the Parents' Bill of Rights.

7. HB 10 (Callender/Sweeney) Expresses the intent to continue phasing-in the FSFP and, if practicable, fully phase it in

- Contains placeholder language to continue the phase-in of the Fair School Funding Plan.

8. HB 11 (McClain/John) Creates the Backpack Scholarship Program (the Backpack Bill)

• House Bill 11 – is set to receive sponsor testimony in the House Primary and Secondary Education Committee on Tuesday, Feb. 28 at 4:00 p.m.

• Qualifies for a Backpack voucher every Ohio student, including existing non-voucher students already attending chartered nonpublic (private) schools and incoming kindergartners.

• Provides a state-paid voucher of \$5,500 or \$7,500 for private school tuition or for specified "educational goods and services" at non-chartered non-public schools and for homeschoolers.

• Reduces frequency of state test administration for grades 1-8 by requiring testing every other year on a school-selected test that is a nationally recognized measure of achievement; applies current high school testing and graduation requirements; and

• LSC estimates it will cost the state \$1.13 billion immediately and annually thereafter to pay for existing non-voucher private school students, homeschool students, and non-chartered non-public school students.

9. HB 12 (Jones/Dobos) Reform function, responsibilities, accountability of state education office to emphasize education, workforce development

- The House companion bill to Senate Bill 1.

10. HB 33 (Edwards) Main Operating Budget (Budget Bill)

• House Bill 33, the biennial budget bill, has future hearing dates available for public testimony scheduled for March 7, 9, 14, 16, 21, 22, and 23. Contact Will if you are interested in testifying.

11. HB 38 (Blackshear/Miranda) Allows school districts to permit students to take up to three mental health days away from school each school year.

• Creates a permissive tool for schools to allow students to take up to three mental health days each school year.

12. HB 47 (Brown/Bird) Requires the placement of AEDs in public and private schools.

• Requires, rather than permits under current law, the placement of AEDs in each building and requires an emergency action plan for their use.

1. **Ohio's Comprehensive Literacy Strategy**

Tony continues to be involved in strategic discussions with several stakeholder groups addressing a comprehensive approach to K-3 literacy. We anticipate the governor's budget proposal to include reforms in this space with funding to assist schools with implementation. Will and Tony will send a proposal to the Executive Committee and then members for their review and discussion following the March 22 Executive Committee meeting.
