Tony Podojil convened the meeting at 10:00 a.m. The primary focus of the meeting was to update Alliance members regarding the most recent legislative activity listed below.

## I. MAJOR BILLS UNDER CONSIDERATION

- a. HB 8 (Swearingen/Carruthers) Parent's Bill of Rights
- b. HB 68 (Click) SAFE Act and Save Women's Sports Act
- c. HB 187 (Hall/Bird) Property Valuation Reappraisals
- d. HB 263 (Hall/Isaacsohn) Property Tax Freeze
- e. SB 49 (Reynolds) Religious Expression Days

Will provided an overview of the bills under major consideration in the General Assembly. Property taxes and property values continue to be the major topic of conversation of lawmakers, and various proposals are under consideration. It is anticipated that the legislature will advance one of the proposals in October or early November as time is of the essence in order for January tax bills to be issued.
