EXECUTIVE SESSION

No Executive Session was held.

MINUTES

Executive Committee meeting minutes from September 2023, were electronically distributed to members prior to this meeting for their review.

John Marschhausen moved, and Chad Hilliker seconded the approval of the minutes for September 2023. The motion passed unanimously.

FINANCIAL REPORT

A. Fiscal Report

Tony Podojil provided a summary of the financial activity for September 2023. He mentioned all dues payments have been received. He also mentioned the Annual Luncheon registration forms and checks are also being received.

A copy of the financial report was electronically distributed to members prior to the meeting.

Thomas Hosler moved, and Brian Poe seconded the approval of the fiscal reports for September 2023. The motion passed unanimously.

EXECUTIVE DIRECTOR'S REPORT

A. Major Bills of Concern to Membership:

a. HB 183 - The Bathroom Bill

The bill is expected to receive a committee vote and a potential House floor vote. Doing so would allow House Republicans with primary election challengers to show voters their conservative credentials with a vote in support of the bill. Timing will be key as only one House session is scheduled for January and then not again until April.

b. HB 187/SB 153 - Property Tax Valuation Changes

The Senate has yet to take up HB 187 for a first hearing despite the committee having multiple times to meet. This potentially indicates the Senate's lack of interest in the House's plan to address historic increases in property values. We are monitoring efforts by some county auditors to limit revenue growth for districts at or near the 20-mill floor.

c. HB 206 - Expulsion Policies

The bill to provide additional expulsion authority to superintendents is expected to be revised in the coming weeks and likely passed before the year's end. Chairman Bird considers this bill a priority for his committee.

d. HB 211 - Free to Speak Act

While this bill has not received any hearings thus far, several members of the House indicate it is important to them and they wish to see it passed. It is anticipated the House may consider this legislation after advancing the bills on its plate currently and may do so in the beginning of 2024.

e. HB 214 - Professional Standards for School Staff

Like HB 206, this bill is expected to pass the House soon. It is a priority for Chairman Bird and many members of the House Majority Caucus.

f. HB 216 - Compliance on Bullying Laws

This bill has not yet received traction, but House lawmakers are expected to address it once HB 206 and 214 are finished.

g. SB 162 - Academic Intervention Plans

The bill is a priority of Chairman Brenner and is expected to clear the chamber, potentially by year's end.

h. SB 168 - Deregulation and Flexibility

Also a preferred legislative item by Chairman Brenner, the bill is expected to undergo modifications over the next several weeks as unions and other organizations have issues with some of the licensure items in the bill.

i. SB 104/HB 219 - College Credit Plus

An interested party meeting with Sens. Brenner and Cirino resulted in the textbook-sharing provision being removed from a forthcoming draft of the bill, but future action is uncertain; Sen. Cirino is primarily focused on advancing SB 83 and will return efforts to SB 104 when that concludes.

j. SB 17- Capitalism and Financial Literacy

The bill is expected to be passed and sent to the governor by the end of the calendar year.

B. ODE/State Board of Education

a. ODE transition to ODEW- TRO Update

The temporary restraining order expired on Oct. 20, and the DEW transition is now in effect. Gov. DeWine selected Jessica Voltolini as interim director until a permanent director can be seated.

b. Science of Reading Lawsuit

A lawsuit challenging the constitutionality and legality of a budget provision regarding the Science of Reading was filed in a Franklin County court. The lawsuit requests for a preliminary injunction, but that has not yet been granted or decided upon by the judge hearing the case.

The Alliance was invited by the Governor's office to participate in a stakeholder meeting to provide feedback and suggestions regarding the skills, knowledge, and experiences to consider when selecting the Director

of Education and Workforce. The group we participated in included representatives from the gifted community, ESC and CORAS.

C. Membership

1. Annual Meeting- Capital Conference

The Annual meeting will be held November 13, 2023, registration forms have been sent to members. We have over 380 guests signed up to join us and are still receiving forms.
