Zoom Meeting Summary Friday, April 4, 2025 10:00 a.m.

In attendance on video conference: Executive Director Tony Podojil and Legislative Consultant William Schwartz and member representatives from 58 school districts.

Tony convened the meeting at 10:00 a.m. The primary focus of the meeting was to update Alliance members regarding the most recent legislative activity listed below:

I. MAJOR BILLS UNDER CONSIDERATION

a. HB 96 – Main Operating Budget Bill

The House Finance Committee on April 1 adopted a substitute bill making changes to the executive budget proposal from Gov. Mike DeWine. The bill contains a bridge funding formula, appearing to move away from the Fair School Funding Formula and, also capping school district carryover balances at 25% and redirecting amounts exceeding that threshold back to property taxpayers. A full summary of the changes is being shared with Alliance members. The House will make a second round of changes to the bill on April 8 and pass the bill out of the House on April 9 where it advances to the Senate for consideration.
